



#### **CEO Briefing Note for Schools and Governors: January 2017**

#### **National News Highlights**

Northern Powerhouse report published setting out education recommendations for 2017

Led by Sir Nick Weller, the highly anticipated Northern Powerhouse (NPH) Schools Strategy was published in November 2016. The independent review was commissioned because of the recognition that schools in the north of England, consistently underperform compared to their southern counterparts.

The NPH strategy sets out a number of recommendations, summarised in a helpful executive summary (pages 4-11) aimed to help address the performance balance. It makes a very interesting read.

The recommendations focus on the following five key areas:

- Building teaching and leadership capacity
- School improvement capacity
- Raising standards by closing the disadvantage gap
- Curriculum
- System Conditions (ie. cold spots across the region)

The work of the Northern Powerhouse is underpinned in our region by the work of the West Yorkshire Strategic Partnership (WYSP), a group instigated by DFE but led by stakeholders from across the region including all five LAs, both Diocese, MAT representatives (including BDAT), system leaders and the Teaching School Council. The WYSP are looking at how the recommendations of the

NPH strategy can be put in to practice. Initial focus includes the roll out of the coasting school agenda and shaping the NPH recommendations on Teacher Recruitment and Retention. **More to follow....** 



In December 2016, the Secretary of State announced two new sources of funding for school improvement for a **transitional period**, to support progression towards a fully functioning school-led system.

The two elements are as follow:

• A £50m per year grant (which will be allocated to LAs from September 2017 with £30m available to cover the initial 7-month









period). The **£50m** grant will go to LAs, allocated on the basis of the number of maintained schools in each LA area with an adjustment for local area costs and a top up to ensure that each LA receives a minimum allocation of £50,000. It will enable LAs to continue to monitor and broker school improvement support for weaker maintained schools in their area, and intervene in certain cases, following the end of ESG funding.

• A £140m (2017-18) Strategic School Improvement Fund which will support school improvement and help to build school-led capacity in parts of the country where it is needed. The £140m fund will be available to maintained schools and academies in need of support. They will be able to apply to the fund either alone, or as a group of schools, with the support of a teaching school/NLE, LA or RSC, to receive additional funding to support school improvement provision. LAs, RSCs and Teaching Schools will be involved in encouraging bids from schools they identify as being on a downwards trajectory on educational performance or financial health; they will identify teaching schools/NLEs/other providers to support those schools. LAs, RSCs and the Teaching Schools Council will be involved in making recommendations at to the prioritisation of bids. More detail is expected soon.

#### New guidance on growing MATs effectively

In December 2016, DfE also published good practice guidance for new and growing MATs based on lessons learned to date. Key sections include growing with care, governance, the importance of the right people and leadership development. For more information:

- **Belle Vue Girls'** retained a good judgement following a one-day OFSTED inspection.
- St Philips Academy moved from satisfactory to an all good SIAMS judgement.






#### **Movers and shakers**

#### The Academy at St James joins BDAT

We are pleased to welcome our tenth academy in to BDAT from  $1^{\rm st}$  January 2017. "The Academy at St James" successfully converted this month and school also opens its doors with a new Head of School this term as Chris Tolson joins the Trust.



#### Further steady primary growth expected.

And further steady growth is expected this year following the Diocesan Board of Education giving approval for East Morton Primary and Trinity All Saints in Bingley to join BDAT. Both schools are aiming to join the Trust in summer 2017 and have already started to join some of our primary and business meetings.

Representatives of the BDAT team (Carol, Helen and Craig) met the RSC in the weeks prior to Christmas for our Department for Education annual health check. At the meeting we talked through our growth plan, our Trust school improvement plan, operational structure and capacity. The conversation included a detailed chat about every academy within the Trust. Following the meeting DfE confirmed that they are satisfied the trust has managed our recent growth effectively and improved internal capacity and capability. While they will need the usual level of detailed due diligence when they come to approving new primaries joining the MAT, this review puts us in a strong position.



## Do you know someone who would be a great school governor?

BDAT currently have a number of governor vacancies across the Trusts and are looking for experienced governors who may be interested in stepping up to take on a Chair role or new governors to support our schools.

The expectations of a governor are to attend all Local Governing Body meetings (approximately 6 per year) along with any committees you wish to serve on. Governors should read all documentation received in advance of these meetings

in order to provide strong support and challenge to the Academy Principal and the senior leadership team. Governors are also expected to undertake training to ensure they have a strong grasp of how educational and financial factors shape and affect their school. The role of a Chair is to act as a key link and communicator between the local governing body and the BDAT Board of Trustees. Chairs are also required to attend the BDAT primary/secondary education committees as requested.
