# **CEO Briefing Note for Schools and Governors: June 2017**

# Purdah puts BDAT growth on temporary hold

Since the last briefing, you will be very aware that Teresa May announced a snap election would take place on June 8<sup>th</sup>. You may not however be as aware of the implications this has for academy trusts and schools on decision making, planning and growth.

I would like to specifically mention two examples:

- 1. The first big implication is that the information we were expecting on the National Funding Formula has been put on hold. This makes planning
  - considerably more difficult over the medium term as future schools budget allocations remain uncertain. I would like to pass on a huge thank you to the staff at BDAT centre and across our schools who nonetheless have worked very hard to submit budgets in line with the Trust statutory accounting timetable.
- 2. Purdah also places restriction on decisions about new schools joining BDAT as no further academy orders can be issued during this time. We currently have four academy order requests with DFE and are hopefully that soon after the 8<sup>th</sup> June we can move forward to welcome these schools in to the Trust in the Autumn. We will of course keep you updated as decisions start to come in.

### **BDAT Business as Usual....**

Despite changes being afoot on the national front, business at BDAT this term continues at pace:

The Trust recieved news of our Schools Conditions fund allocation this term allocating BDAT schools just over £750,000 to improve and maintain our school building portfoilo. Following a successful pilot bidding programme we have now allocated just over £550K of the funding across 8 of our academies. A further bidding round will run in the Autumn term.

- In April 2017, BDAT was delighted to launch our first Employee Benefit scheme called "BDAT Benefits". - Finally we are delighted to report and thank all our schools who took part in the new
   Safeguarding audits this year. All school have now been audited and are compliant. We have
   signed up to another round of audits for new schools joining BDAT and shorter health checks
   for our existing academies for next year and we will also be providing free health and safety
   audits as part of our core offer. More information to follow on both programmes shortly.
- And speaking of audits, as a growing MAT we have now reached the point where from 2017-18 we will be legally required to have a independent internal audit across all areas of Trust business. This is in addition to our external financial audit. We are currently developing this programme of work and more information will follow shortly.

So far, staff at Christ Church have raised over £1500 to continue the programme, and hope to raise the remainder of the £2600 target total through further fundraising.

Finally staff and pupils at **Westminster Academy** took part in a garden party celebration in May to celebrate the launch of their new outdoor early years provision. Following a £51,000 investment the exciting new area encompasses a range of areas including a castle and moat, maths shed, mud kitchen, sandpit and bug hotel – each designed by a specialist EY Consultant to bring learning to life. The school also proudly showcased an improved indoor early years space for their 3-5 year old pupils designed to bring every day learning to life.
